### **Final Letter Before Application to International Court of Justice**

I congratulate you on your new position, which I was not informed of until recently. This might explain the problem we find ourselves entangled in.

When I was invited by your predecessor to present my research data your Director of Science opened a file which contained confidential information on my career and qualifications. It was essential to me that my name remain out of the news and that my research was to be acted upon my representatives of your department.

There was unanimous support for Scan Pyramids to proceed immediately with scanning the Southern Passageway of the Subterranean Chamber of The Great Pyramid of Khufu.

Without departmental support, Zahi Hawass prevented this by happening by instructing Ashraf Mohie to stall. Later Hawass also appeared on television telling lies about me which slandered the reputation of me and my family – both of whom have a long history of supporting the Egyptian government.

Because I am a friend of Egypt, I am making one final appeal to you for action which might forestall my team from punitive action in the United Nations International Court of Justice.

It is with regret that I must inform you that unless we receive a commitment from you that the ‘agreement to carry out scanning will be fulfilled as a priority’, then then the following names from the Supreme Council of Antiquities and Ministry of Tourism & Antiquities will appear on the court documents to follow:



- **Minister Sherif Fathy** – Breach of Agreement & Copyright Infringement
- **Zahi Hawass** – Slander & Professional Damage
- **Mohamed Ismail Khaled** - Breach of Agreement & Copyright Infringement
- **Ashraf Mohie** - Breach of Agreement & Copyright Infringement
- **Sahar Mabrouk Abbas Ghaidan** – Obstruction of Justice & Obfuscation

Application has been made for punitive damages of \$200,000,000 USD in accordance with international law and historical precedent along with damages for the Sovereign States of the USA, United Kingdom, Canada, Egypt & Israel.

You are advised, without prejudice, to suspend Zahi Hawass from all departmental representation until the judge presents his ruling or additional subsequent charges might be made following this letter.

I will advise my people to withhold action for 7 days more to give you a chance to make contact and confirm your desire to avoid a legal battle. I hate lawyers but you and your team have offended my generous nature.

I gave Egypt my research as a conditional gift and asked only for anonymity. Now the international media have published my work and my name when I insisted that you maintain my confidentiality. You have permitted Zahi Hawass to slander me without even knowing who I am, but he has also robbed Egypt of a wonderful and prosperous future by opposing my research. Let us hope it is not too late.

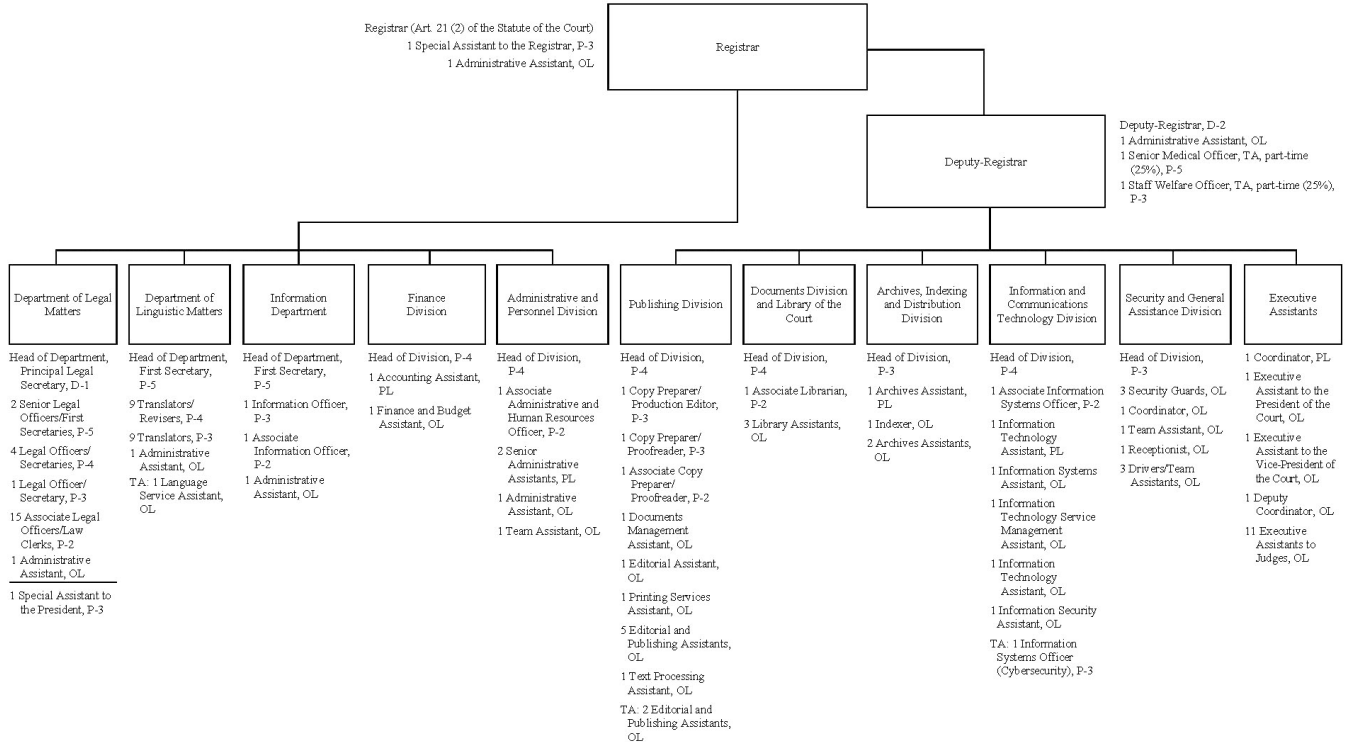
