Dear Minister Sherif Fathy

### **Proposal to Avoid Action by United Nations International Court of Justice**

I was unaware of your recent appointment which explains why my recent [correspondence to Ahmed Issa](#) has not been replied to. In this short, but informative email with the relevant links to media news publications and research data, you will be able to act to prevent any further catastrophe taking place. Be assured of my sincere interests on behalf of your department and the Egyptian people.

It is necessary for the documents linked in the email to be read also, in order for the importance of my message to be fully understood.

A serious international incident has broken out, and will soon grow beyond our control unless action is taken immediately. The [international news media](#) has gained access to our project when I was assured of anonymity when I first met with your Science Director and Secretary Generals. It was the only demand I made for myself when handing over my scientific research to your team. Now the [Jerusalem Post](#) (the most respected journal in Israel) has published details which have been responded to angrily by your own [Egyptian Media outlets](#) ([One](#), [Two](#), [Three](#), [Four](#), [Five](#), [Six](#)) including [TV DMC](#), stirring up hostilities between the two countries - something I was determined to avoid. [Social media](#) is reporting now and the news is spreading. [Television news channels](#) in the United Kingdom [and beyond](#) have now begun reporting.



Your own [Zahi Hawass is now slandering](#) me by telling lies which have no accuracy. You just have to read the long list of letters and documentation to and from your [Supreme Council of Antiquities](#) team to know that what he is saying about me is untrue. I have been courteous

and truthful in all my dealings with your team, as I have been welcomed with courtesy, kindness and enthusiasm from your [representatives](#) for many years now. You will see that I have endeavoured throughout to keep your [Prime Minister](#) and [President](#) updated and involved, seeking their support at all times.

It was my own choice to give my research data to aid Egypt's Tourism industry over and above the [Israeli Antiquities Authority](#) whose own Managing Director has “wished me well” in our mission to excavate the Ark of the Covenant.

Until Zahi Hawass got involved, it was my sincere belief that the delays over the last five years have been caused by bureaucratic failings rather than any malicious intent on the part of any of your people. In fact, it was [Ashraf Mohie's](#) earnest plan to expedite the muon scanning immediately, when I met with him and [presented my complete dataset](#) on the 20th October 2022.

At that point, he agreed to urge the Scan Pyramids Team to begin scanning the Southern Passageway of the subterranean chamber the very next week. That is until Zahi Hawass stood in the way. Why is this man permitted to interfere in our progress when he isn't even officially included in the scientific team?

I will do my utmost to keep the Americans from prevailing upon you, as their [Presidential Council for Science & Technology](#) were keenly interested to see my research acted upon during our meeting in December 2020.



You should know that I even made a recent appeal to the [President of the United Nations International Court of Justice](#) to resolve this misunderstanding in a friendly way. But I am worried that a ruling by a Supreme Court Judge in the United Kingdom might force the International Court of the United Nations on to a stage two application; this would be a point of no return I think. As a result, we now have the [Prime Minister of Lebanon](#) involved. To my dismay, the [Vatican has chosen to make an official comment](#) on behalf of the 2.2 billion christians in the world today.

Dearest Minister Fathy, I appeal to you in the interests of peace and reconciliation, scientific discovery, economic revitalisation and all that is good and true...to intercede on my behalf and the behalf of the Egyptian people, by simply carrying out what was agreed at our very first meeting with your predecessor, Dr Waziri and the Science Director Mohamed el Seaidy.

Direct your scan pyramids team to conduct the agreed survey of the Southern Passageway in the subterranean chamber of the Great Pyramid of Giza.

If you do this, and share the results with me, then our agreement is fulfilled, action is taken and catastrophe is not only averted, but there is real and substantial data to support the hypothesis that you will find the Ark of the Covenant, the Tomb of Khufu and the sarcophagus of Jesus Christ. Should you be successful, millions of Muslims, Christians and Jews ([from a base of 4 Billion](#)) will flow to Egypt on religious pilgrimages to the Pyramids and the new Grand Egyptian Museum; and I will come in July 2025 to assist you. If I am wrong, you will never hear from me again.

You have the power to turn a potential international disaster into a political, economic and scientific triumph. My warm wishes are with you. I am at your disposal.

Please reply with your decision so I may endeavour to stall any further action by the Court, media, governments and religious bodies.
