



Manifesto for Peace

in the Middle East

Justification by Blood:

My name is Dr Gregory Warner and I am a direct descendant of Baron Lionel Nathan de Rothschild of the Rothschild Banking dynasty; [Lionel Nathan de Rothschild of Exbury House](#) was my great-grandfather. He liked to say that he was “a banker by hobby and a gardener by profession”. This is confirmation of my bloodline and justification for my voice on matters pertaining to the Middle East & Egypt.

The Rothschilds were instrumental in the formation of the State of Israel ([Balfour Declaration, 2nd November 1917](#)), and in the funding of the Suez Canal for the British Government in Egypt (1875) - the London banking house of N M Rothschild & Sons advanced the Prime Minister, Benjamin Disraeli, acting for the British Government, £4million to purchase the Suez Canal. Disraeli was a close personal friend of Lionel de Rothschild, and the purchase was made on a gentleman’s agreement, an unsecured loan for a sum equivalent to several £billion today was advanced on the shake of a hand – a gesture which is unthinkable today.

My grandfather was given the name of his father, Lionel, by his mother Esther Carpenter, who was described as “a very beautiful woman” by my own father, Michael. These stories and traditions have been passed down orally through five generations of our branch of the Rothschild family tree, and are supported by several aging documents recording our history; now in the possession of my own sons today.



Justification by Deed:

Although it might be an effective starting point, it is not enough to say that ‘one is justified by one’s family’ to involve oneself in matters of international diplomacy. The problems, and threats to international security, also necessitate measurable and distinct actions which provide the foundation and starting point for any meaningful dialogue.

It all began when I contacted the Israeli government regarding a discovery which I had made. It would not be entirely correct to call this discovery an accident, yet it is patently true that it was a product of serendipity...following years of difficult and intensive study. There is a popular philosophy in business that “you make your own luck”, and I suppose one could say that the events I will describe are evidence of this.

I initially wanted to share my news with Israel, but after receiving brief and [tepid responses](#) from their representatives in 2019, I decided early on that they did not deserve to receive what I was offering. Soon after I approached the Egyptian Ambassador in Washington DC and received warm and courteous support, both initially and subsequently from their scientists, politicians and departmental representatives.

Case and Point:

On the 30th of October 2020, in the midst of the worst pandemic in living memory, I held a [Zoom meeting](#) with the Science Director of the Supreme Council of Antiquities in Egypt. Wherein I presented the first stage of a research caseload that resulted in the director exclaiming that I had made a discovery which was a “[scientific revolution...to benefit all humanity](#)”. A fact which I will attempt to outline below, although to fully understand the hypothesis one who have to study the “further reading” links provided below. Sufficed to say, that the data is extensive, correlated and triangulated using Hebrew, Christian and Muslim historical documents; all relevant to the longstanding conflict. Immediately following this presentation, I was grafted into the [Scan Pyramids Mission](#) team as a special adviser to the Supreme Council of Antiquities, and a long and exhausted dialogue - which has continued to this day – was initiated.



The evidence will support the fact that I have consistently requested anonymity with [no financial reward](#) for my work. However, my desire for anonymity proved impossible and at the very least, impractical; and although I have been forced to release both my research and my name to the public, I ask that interested parties focus on the data and not the person, in keeping with scientific best practice. The research was undertaken without prejudice over a period of ten years. The [confidentiality and exclusivity clauses which were attached to the research have been rescinded](#), as of April 2024.

The Final Solution to the Conflict

There can be only one solution to the Middle-East conflict. That is not such an unreasonable statement considering the fact that it would appear that everything else has been tried! More importantly, the conflict is fundamentally about land, and who has the right to occupy it. So, what if one were to say that ‘Israel is fighting over the wrong land’? Furthermore, what if there happened to be irrefutable scientific data to support this claim?

The answers to these questions are clear...**they are** and **there is!**

The conclusions arrived at, by means of the [GARP Research Project](#), state that the “Holy Mountain of Israel” is none other than the Great Pyramid of Egypt – also known as the Pyramid of Khufu. Furthermore, listing the names in chronological order, this “artificed mountain” is also the “Mount of Olives” of Hebrew/Christian tradition, and the “Jabal al Nour” (the mountain of light) of Islam or the Mountain of Mohamed – Most of us will be familiar with the saying “If the mountain will not come to Muhammad, then Muhammad will go to the mountain”. This being true, the “land of Israel” or the “promised land” resides in Giza, an area of land which spans everything West of the Nile River and South to the pyramids complex of Dahshur.

Genesis 13:14-15: God instructs Abram to ‘lift his eyes and look from the place where he was to the north, south, east, and west, promising to give all the land he sees to him and his descendants forever’ - one of the many references to the Great Pyramid which lies on the four cardinal points of the compass – North, South, East and West. Of course, the Israelites did eventually move eastward, following several battles which were led by Joshua, the son of Nun.



These claims are not only supported by intellectual study & qualified supposition, but also by exhaustive and often dangerous fieldwork.

Despite all this, it is with sadness that I now accuse my colleagues, the Egyptian scientists who hitherto have called me “friend”, with the crime of obfuscation which is motivated by the fear of a military incursion by Israel, and not by scientific integrity. In the latter days of our dialogue, I was repeatedly asked if Israel “will come and take our land” (director of science – Mohamed al Seaidy). Meanwhile the innocent continue to die every day in Gaza, Lebanon and Israel, while a conflict which threatens to engulf the whole world could be terminated by revealing the truth about Abrahamic religious and anthropological history.

Therefore, it is important to recognize, that the Egyptian scientists and archaeologists, quoted in the supporting documentary, photographic & video evidence, have not done this thing because they are unconvinced by the research data presented, quite the contrary! The reader will see from the published information that they are fearful of geopolitical instability because they *are* convinced that the hypothesis is correct!

Now, before anyone accuse me of being motivated by religious fervor, I wish to make it abundantly clear, that I have no religious proclivities – only the unshakable conviction that all religion is darkness.

Notwithstanding this, the religions of the world all play an important role in tracing our anthropology and foretelling our prophetic future. A claim which has been painstakingly elaborated upon in my research - using [Quantum Theory](#) – and further substantiated by US military research and detailed scientific papers published by experimental scientists such as [Stephan A. Schwartz](#) – who provided access to his papers on “non-local consciousness”, on the 8th of November 2021.

The conclusions drawn from the analysis of all Abrahamic religious texts, was rooted in etymology, or the study of the root meaning of words, then moved onto the study of religious prophecy and its correlation to quantum events entangled within the human endocrine glands



and supported by astronomical observations which prove '[binary star theory](#)', as it pertains to our own sun and recent astronomical phenomena.

The most pressing problem, which we are presented with today, is a society which preoccupies itself with trivial and foolish nano-temporal events, which are described as “social” media but are devices of technological addiction by their very design.

The now gargantuan technology entities, who use or personal data for corporate gain, and the megalomaniacs who own them, gobble up media and news entities at an alarming rate – thus acquiring the power to influence and control our thoughts and behavior to their own selfish ends.

This leads to journalism which is stale, repetitive, mundane and heavily censored. Maybe not always overtly, but more insidiously, in the sense that any departure from the prevailing government's agenda, or social change programs, is frowned upon and risky to one's career prospects. Risks that few journalists are prepared to take, considering the burgeoning personal indebtedness which the citizens of our developed economies have accumulated.

The same is also true of scientific research and academia. A thesis which builds upon the prevailing themes or upon the published work of one's mentor, is much more likely to succeed in peer review and grant funding, than any other competing work which might be important, original and transformative. The latter is much more likely to receive intense and unjustified opposition from scientific peers and institutional colleagues.

These professional and academic impairments are systemic today. That is to say that they are endemic to the very organizations within which we operate and significantly retard our ability to change, improve and innovate as a species.

Global politics too, has never been so precarious and the threat to our individual sovereignty is a clear and present danger. Those elected to serve the people no longer speak for them, while they implement policies that undermine and harm the electorate...and they do so with relentless impunity.



Meanwhile, the gap between those with exceptional wealth and those with nothing grows at an exponential rate – accelerated by unprecedented monetary expansionism. That which we call a “free market” in developed economies, and was designed to create competition and price suppression, has resulted in the very opposite, a cartel of corporate giants with little and diminishing oversight, and near absolute price control.

These social, political and economic factors can only lead to one inescapable outcome...[Revolution!](#)

The reason that I include these issues, which one might say ‘falls outside my purview’ as a scientist, is because we are now presented with the opportunity to make this a “scientific revolution” as stated earlier by the Science Director of the Egyptian Supreme Council of Antiquities. It is possible to avoid further bloodshed in the Middle East and a brutal and bloody revolution by the proletariat, which almost certainly will follow should we do nothing to avert it.

Call to Action:

Now this is the point of what I am saying. There exists today, here and now, unquestionably the instrument of peace in the Middle East. The Ark of the Covenant is hidden within a hidden twin subterranean chamber of the Great Pyramid of Egypt. This has not only been proven by a vast array of accumulated research, but also, fieldwork which has taken me and other leading archaeologists assigned to me by the Egyptian government, to within a few meters of the “cave of the patriarchs” and the ark box itself – which is an anthropological time capsule containing biological enzymes which can be carbon dated. Of course, the contents of the sarcophagi also provide biological material for further scientific study.

At every stage of my dialogue with its representatives, I have repeated my desire to remain nameless and receive no financial reward.



Hardcopy and digital folders of the entire research project is stored securely at the headquarters building of the Supreme Council of Antiquities in Cairo. They were deposited there on the Friday 21st of October 2022; in the presence of: The Minister for Tourism & Antiquities - Ahmed Issa, Secretary General of the Supreme Council of Antiquities - Dr Mustafa Waziri, and the Director of Science - Mohamed el Seaidy.

Indeed, it was personally delivered at the request of Ashraf Mohie, Secretary General of the Giza Pyramid Complex, following a meeting and audio-visual presentation of the complete, and final material that very morning. After the meeting he instructed that the folders containing the finalized research be taken to his boss Dr Waziri with a personal message from him - “tell him that it’s all good with me!”. Ashraf is a straight-talker!

Upon receipt of the research data, there was only one precondition which was to be maintained in order to retain exclusive position of the material...that progress continues towards the muon radiation scanning of the ‘area of interest’ by Scan Pyramids Mission team of scientists – a condition which they have failed to deliver on. The fact that the project has been slowed, by fear, is patently unacceptable, unscientific and has necessitated the publication of the research data at www.garp.space

...a task which is considerable and ongoing.

The “call to action” for anyone with journalist integrity, fearless in the face of growing censorship, and all those who retain a love for science, scientific discovery, religious devotion, and a desire for peace in the Middle East is this: **publish, share and investigate the claims made in this manifesto, do it now, and do it with all the vigor and zeal of people who desire to live in a world of peace, truth and justice.**
